### Club And Flying Site Rules

The following rules have been set forth and enacted by the officers of this club in accordance with the requirements set forth by officials governing all activities on current flying site.

Your signature below will signify that you have read, understand, and will comply with the all **Club Rules, By-Laws, and Nassau County License Agreement**. Failure to comply with these rules may result in the loss of your club membership and flying privileges with the 'Island Flyers R/C Club'

1. All active members guest will have in their possession their current AMA membership card while flying on site and will present the card on demand. Intro flight and Non flying guest are exempt.
2. All flying operations will be done in accordance with the official AMA National Model Aircraft Safety Code.
3. Flying is permitted in front of pilot pads; **Do Not Fly Over Pits, Spectators or Parking Area.**
4. **Pilots must stay in complete physical control of aircraft while in pits.**
5. Only radio controlled and line controlled aircraft with electric or piston-powered engines with mufflers are permitted to operate in landfill. **No Rockets or Turbine** powered aircraft allowed to operate in landfill.
6. **No littering, or trashcans allowed in landfill**, Please take your trash back with you.
7. Park vehicle in designated parking area only.
8. All members are required to participate in all maintenance needs of field when required.
9. Solo flight of new members or pilots, will only be conducted after a check out from experienced club member.
10. Members are responsible for their guest actions and any fee's while in park.
11. Members agree to any reasonable assessments needed to support clubs requirements as stated in bylaws
12. Respect and sportsmanship like conduct is required in landfill at all times.
13. **Nassau County Landfill Director has allow the front gate to be unlock but appear close and the second gate open while flying at the field. If front gate is found open or unmanned could result in loosing flying site. Last man out should lock all gates. Leaving gate open, unlocked or unmanned may lose club membership immediately and flying site for others.**
14. **D.E.P. and Nassau County has dictated we not drive around landfill. Club members will be confined and restricted to the road leading to flying site parking area only. No driving around or on mounds with any type of vehicle. This will be a zero tolerance issue. Any club member or their guest violating this policy will lose club membership immediately.**
15. **Copying of gate keys for the purpose of giving/loaning to a non-member or a guest will lose club membership immediately.**
